#### Background

# Demonstrating our commitment to learners and employees (meeting our duties)

- Making and access to learning: Bearsted Primary Academy publicity and learner recruitment procedures will be designed to encourage applications from all sections of the community and from all levels of ability.
- Bearsted Primary Academy will ensure that admission procedures are user friendly and avoid unnecessary barriers to access for intending learners.
- Bearsted Primary Academy will continue to identify and respond to learning needs within the community and will encourage widening participation from underrepresented, disadvantaged or excluded groups.
- Equal opportunities data will be collected, analysed and used to inform the planning and decision-making process of our Admissions and Marketing policies.

## The Learning Environment

Bearsted Primary Academy is committed to the development of learning environments that are welcoming and safe for all learners.

Bearsted Primary Academy will continue to develop its facilities and accommodation to improve access for people with learning difficulties and/or disabilities.

### **Teaching and Learning**

- All teaching staff will ensure that course delivery is free from bias, stereotyping and discrimination.
- Subject staff and mentors will encourage learners to explore issues of equal opportunities and diversity where such an opportunity exists within the curriculum.
- Raising awareness of equality and diversity issues will be a part of the curriculum for all students.
- Within its available resources, Bearsted Primary Academy will ensure that learners with learning difficulties and/or disabilities receive appropriate additional support to meet individual learner needs.
- Curriculum teams will regularly review course design and delivery to meet the various learning needs and styles of learners and to improve access to learning.
- Bearsted Primary Academy will ensure that the views and perceptions of learners are included in the process of curriculum review and self-assessment and also curriculum development.

### Staff Recruitment, Training and Development

- Bearsted Primary Academy embraces equal opportunities and diversity in all its aspects, and aims to employ a workforce that reflects, at every level, the community it serves by ensuring job advertisements are targeted at both mainstream and minority communities.
- Bearsted Primary Academy will treat all employees with respect and dignity, and seek to provide a working environment free from harassment, discrimination and victimisation. Bearsted Primary Academy will not tolerate any form of discriminatory behaviour against its employees, either from other employees, students or members of the public.
